

Florida Senate Bill 180

SB 180: *Emergencies* passed by legislature on May 2, 2025; Governor DeSantis signed into law on June 26.

Numerous impacts to local governments, including:

- Informational requirements for local government websites,
- CEMP requirements,
- Post-storm building permitting,
- Debris management,
- Local building inspections and fees
- Post-storm construction moratoriums,
- Substantial improvements and repairs, including assessment values



FEMA BCA Toolkit Updates

On June 04, 2025, FEMA released the following changes:

- Discount Rate Update (3.1% to 7%)
- Removal of Social Benefits
- Removal of Riverine Future Precipitation Impacts and Federal Flood Risk Management Standard (FFRMS)
- Removal of Distributional Weights
- Updated Inflation Index for May 2025 (1.67 to 1.7)
- Pre-calculated benefits for certain project types updated



Duval County Local Mitigation Strategy (LMS)

The LMS is a planning process required by the State of Florida to oversee a plan of mitigation initiatives to help the county be resilient and anticipate and prepare for hazard avoidance. FEMA and the State of Florida have approved the 2020 Duval County LMS. The process is overseen by the Duval County Local Mitigation Strategy Advisory Committee, also known as the <u>Duval Prepares</u>. Members meet quarterly to review and add new projects to the current mitigation initiatives.

Grant Updates

Building Resilient Infrastructure and Communities (BRIC)

In April 2025, FEMA eliminated the Building Resilient Infrastructure and Communities (BRIC) program and canceled all BRIC applications from Fiscal Years 2020-2023. Any funds not yet distributed were returned to the Disaster Relief Fund or the U.S. Treasury.

Program Highlights

• Application Status: Property owners will receive updates on their application status by the end of August 2025.

Key Accomplishments:

- 302 property owner cost share matches received
- 13 inspection vendors onboarded
- 11,560 calls handled through the call center
- Successful outreach events with 1,128 in-person attendees
- Program Updates:
 - Over 12,000 applications from residents across 64 counties



Grant Updates Elevate Florida

Program Status

• Each Elevate Florida applicant is moving at a different pace depending on position in priority, responsiveness, and other factors such as National Flood Insurance Program status and individual circumstances..

Cost-Share

• Due to the large number of applications received, **reduced cost-shares for Repetitive Loss and Severe Repetitive Loss properties are no longer available**. Cost-shares for the Program are 75% federal and 25% residential to support more homeowners across Florida.

Note: FEMA policy limits federal funding to \$220,000 (hard costs) for Mitigation Reconstruction projects. Property owners will need to pay for any extra costs beyond this \$220,000 amount.




Elevate Florida Program Snapshot Month of May 2025






Elevate Florida: Applications Map

- Martha Ann Drive Acquisition (Removed from further consideration due to FMAFY24 application being recommended by FDEM)

 - Previously submitted to BRIC, resubmitting through HMGP due to BRIC application being terminated
